2019 Annual Pass and Fee Structure

INDIVIDUAL PASSHOLDER

Option 1 - Green fees only: Entitles the Annual Pass Holder to unlimited green fees.
Price: \$ 1035.00 with tax included.

Option 2 - Green fees & cart: Entitles the Annual Pass Holder to unlimited green fees and unlimited cart use.
Price: \$ 1,725.00 with tax included.

FAMILY PASSHOLDERS

Option 1 - Green fees only: Entitles the Annual Pass Holder to unlimited green fees.
Price: \$ 1,580.00 with tax included.

Option 2 - Green fees & cart: Entitles the Annual Pass Holder to unlimited green fees and unlimited cart use.
Price: \$ 2,585.00 with tax included.

ANNUAL TRAIL FEE: Annual Pass Holder may use his or her own cart on the golf course. (No cart storage is available.)
Price: \$ 345.00 with tax included.

GOLF CART RENTAL:

Green Fee Only Annual Pass Holder: Golf cart not included. Pass Holder may walk the course or pay the daily cart rental fee. Cart rental fee is required when playing with another pass holder.

Green Fee & Cart Annual Pass Holder: Golf Cart is included. The per person fees are structured that in the event there are two or more players in your group, two players to a cart **are required** unless there is an odd number of players.

Anyone not included on an Annual Pass must pay a cart rental fee if they are riding with a Pass Holder who has an Annual Pass.

Pass Holders are liable for any damage to a cart due to misuse or negligence.

TERM AND CONDITIONS

This agreement for Annual Passes is made subject to the terms and conditions set forth below:

1. All applications for Annual Passes shall be approved or rejected by Heritage Hills Golf Course.
2. An Annual Pass is non-transferable.
3. An Annual Pass includes golf privileges only with options for golf car rental or trail fees. Playing privileges under all Annual Passes are subject to the rules and regulations, schedule of operations, and course availability, which may change from time to time, as established by Heritage Hills Golf Course. Annual Pass Holders that do not adhere to said rules, regulations, and schedules may forfeit their Pass Holder privileges. Annual Passes do not include share interest or ownership of any kind in Heritage Hills Golf Course.
4. Annual Passes will run for one full year, beginning on March 1 and ending on February 28. For new Annual Pass Holders that join during intermediate months the annual fee will be prorated based on the number of months remaining from the time of sign up until February 28. Prorated Annual Passes will only be accepted for the initial year's Pass and will not be accepted for subsequent years for Pass Holders.
5. Any applicant who is ten days delinquent in payment of their Pass Holder fees forfeits all rights to said Pass and any fees paid.
6. Annual Pass Holder fees will not be refunded at any time.
